for 2020 Scholarships

Rusk County Electric Co-op (RCEC) has a scholarship fund to assist its members' graduating high school seniors who desire to further their education. Scholarships are awarded to students based on several criteria: demonstrated civic responsibility, scholastic achievement, and financial need.

QUALIFICATIONS

High school seniors and non-traditional students (those students attending private, parochial, or home school) are allowed to apply.

The applicant's immediate family must be an active member of RCEC.

APPLICATION

- 1. The scholarship application must be personally completed by the applicant, and
- 2. Must be accompanied by the School Certification form & High School Transcript;
- 3. Two letters of recommendation are to be signed by the applicant [in the box] and then completed by a teacher, principal, or counselor from the high school the applicant is attending. They cannot be from a relative. If the student is home schooled, the letters of recommendation may be signed by individuals in their community.
- 4. Picture for publications (wallet size)

ADMINISTERING OF FUNDS

- 1. All scholarship funds will be paid directly to the educational institution of your choice (university, junior college, technical or vocational school).
- 2. The recipient must enroll in classes and contact RCEC for payment of the scholarship within one year after high school graduation.
- 3. A minimum of twelve semester hours as a full-time student is required for college; full-time enrollment in a technical or vocational school is required.
- 4. If the recipient does not attend school and contact RCEC for payment within one year following graduation, the scholarship reverts to the scholarship fund.
- 5. The scholarship will be paid after sending proof of enrollment in the required semester hours to RCEC's Scholarship Committee.
- 6. It is the recipient's responsibility to contact RCEC for payment of the scholarship.
